INDEVCO North America excludes all other express and implied warranties, including warranties of merchantability and fitness for a particular purpose. INDEVCO North America disclaims all liability arising out of the misuse, improper installation, or improper storage of the product. Any claim based on a product defect covered by INDEVCO North America's limited warranty must be made as directed in the [section dealing with claims]. Purchaser waives claims not made in accordance with [section dealing with claims].

INDEVCO PACKAGING SOLUTIONS (PLASTICS):

- Storage conditions <85 Fahrenheit @ 50±15% RH.
- Used reels repacked in the original or an adequate replacement packing form.
- 5% minimum defective quantity for return.
- Labels and unused samples presented in case of claims.

INDEVCO BUILDING PRODUCTS:

- Storage Conditions – House Wraps, Drainage Wrap and Roof Underlayment should be stored out of direct sunlight. Cover or store inside prior to installation (See specific product information for UV exposure limits). Tapes and adhesives should be stored in climate-controlled conditions 50°F-90°F, extreme cold or heat can affect adhesive properties.
- Labels and unused samples must be presented in case of claims.
- Shelf Life is product dependent - tapes, flashing and sealants have a 12-month shelf life.
- All Product must be in resalable condition for returns.
- Claims must be submitted within 30 days of shipment. Samples and inspection must be allowed for claim processing.
- All returns are subject to restocking fee of 15%.

INDEVCO PACKAGING SOLUTIONS (PAPER):

- Storage Conditions – Out of direct sunlight - Must be stored inside.
- 12-month shelf life from the date of shipment, unless otherwise noted.
- Properties such as moisture and corona treatment can change over time depending on storage conditions, material should be used on a first in first out basis.
- Claims must be submitted within 12 months of shipment. Samples and inspection must be allowed for claim processing.
- 5% minimum defective quantity for return.
